Replacement of this transmitter by a high power (10KW) transmitter and establishment of a full-fledged TV Studio Centre at Bhubaneshwar as well as of eight new low power (100W) TV transmitters, one each at Baripada, Sundergarh, Baleshwar, Keonjhargarh, Bolangir, Phulbani, Jeypore and Chatrapur, are included in the VII Plan of Doordarshan.
