THE MINISTER OF WATER RESOURCES (SHR B. SHANKARANAND): (a) to (c) The Government of Orissa have recently informed that as per rehabilitation policy framed by the State, 9559 displaced families of 114 villages were identified for resettlement as a consequence of Rengali Dam Projefe. Of these 9512 families have already been provided with prescribed benefits and the State is taking necessary steps in the remaining cases also. The High level Rehabilitation Committee of the State has decided to extend resettlement and rehabilitation benefits to another 1067 families in Hard core villages. The State Government has proposed to complete entire resettlement and rehabilitation programme by March, 1987.
