- (b)whether Government are considering a proposal for regularizing some of the major unauthorised colonies; and
  - (c)if so, the names of such colonies and the steps being taken in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT (SHRIAJAY MAKEN): (a) to (c) The Union Government on 8.2.2007 has approved a proposal regarding revision in the guidelines for regularization of unauthorized colonies in Deihi. Colonies existing as per aerial survey of 2002 and fulfilling the prescribed conditions are eligible for regularization.

The Government of National Capital Territory of Delhi (GNCTD) had invited applications from Societies/Associations of unauthorized colonies existing as on 31.3.2002, seeking regularization and received 1432 applications. Further, 107 applications have been received by GNCTD in response to a later advertisement inviting applications. GNCTD has informed that verification on site of these applications has been taken up through different agencies.

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT (SHRI AJAY MAKEN): (a) to (d) The Ajmer-Bisalpur Water Supply Project Phase-II with an approved cost of Rs. 188.73 crore has been sanctioned for supply of additional quantity of water to Ajmer, Pushkarand allied beneficiary towns, namely, Kekri, Sarwar, Kishangarh, Beawar, Nasirabad and other rural areas of the district.

The State Government has awarded work order for the Project for the transmission main. The line is expected to be commissioned by 31st December, 2007.

Period of implementation of the project is 2 years.

## Improving standard of Hockey and other sports

THE MINISTER OF YOUTH AFFAIRS AND SPORTS (SHRI MANI SHANKAR AIYAR): (a) and (b) The Government are concerned over India's performance in hockey, which has been much below expectations in the recent years. The Indian Hockey Federation, which is primarily concerned with the devetopment of the sport in the country and the performance of Indian Teams in international events, has stated that they are making sustained
