Table of both the Houses of Parliament in February, 1986, contains, inter-alia, details of units incurring losses during the years 1983-84 to 1984-85.

(d) and (e) The decisions regarding location of Central public sector enterprises are taken by the Government on broad techno-economic considerations and it cannot be pre-determined on a state-wise basis.

## Financial assistance for construction of courts in Andhra Pradesh

1785. SHRI PRABHAKAR RAO KALVALA: Will the Minister of LAW AND JUSTICE be pleased to state:

- (a) whether there is any proposal to give more financial assistance by the Central Government for the construction of Courts in Andhra Pradesh; and

THE MINISTER OF STATE IN THE MINISTRY OF LAW AND JUSTICE (SHRI H. R. BHARDWAJ):
(a) The Central Government have approved the proposal to construct 46 buildings for existing courts during 1985-89 at a cost of Rs. 249.49 lakhs with the grants-in-aid recommended by the Eighth Finance Commission.

(b) The State Government have intimated that 11 District Courts, 22 Sub-Courts, 42 Munsiff Magistrates Courts and 37 Special Second Class Magistrate Courts have been established from 1982-83 to 1984-85.
