THE MINISTER OF STATE THE MINISTRY OF LABOUR (SHRI P. A. SANGMA): (a) Inaugurating the participative management scheme in the Indian Telephone Industries on August 14, 1986 at Bangalore, the I.T.I. Chairman is reported to have given details of the scheme. scheme provides for a multi-tiered structure with a Joint Management Council at the Apex and a maximum of five levels in the Functional Management Councils in the Unit level. The scheme also provides for training of workers and officers the participative style of working.

(b) and (c) The Government of India introduced a comprehensive scheme on Workers' Participation, applicable to all Central Public Sector Undertakings, vide its Resolution dated the 30th December, 1983. 91 Central Public Sector Undertakings have so far implemented the scheme at the shop floor plant level. A Tripartite Committee reviews the progress in the implementation of the scheme.
