## Amount advanced to Bombay Dyeing Company by Consortium Banks

- (c) What is the amount advanced by Consortium Banks towards such capitalisation?

THE MINISTER OF STATE IN THE DEPARTMENT OF EXPENDI-TURE IN THE MINISTRY OF FI-NANCE (SHRI B. K. GADHVI): (a) to (c) The Union Bank of India

has reported that in the Annual Report 1984-85 of Bombay Dyeing Manufacturing Company Ltd., an amount of Rs. 54.68 crores is shown as balance carried forward under the head "expenditure pending allocations" in respect of DMT project of the company. The Union Bank of India has further reported that the banks have not advanced any amount towards capitalisation of these expenses.

## Super Power rivalry in the Indian Ocean

2060. SHRI MUKHTIAR SINGH MALIK: Will the Minister of EX-TERNAL AFFAIRS be pleased to state:

- (a) whether there has been considerable increase in the Super Power rivalry in the Indian Ocean at present:
- (b) whether the Government of India propose to convene an international conference to give practical shape to the United Nations Resolution so that vast stretch of waters be declared Zone of Peace; and
- (c) if so, what are the details in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL K. NATWAR AFFAIRS (SHRI SINGH): (a) There has been a steady increase in the presence of foreign naval vessels, including those of the Super Powers, in the Indian Ocean over the past few years.

(b) and (c) The UN General Assembly, at its 40th Session in 1985, adopted by consensus a Resolution for convening of the Conference on the Indian Ocean under UN auspices at an early date but not later than 1988. There is no proposal for India to convene a separate conference on this matter.
