## FINANCE be pleased to state

- (a) whether it is a fact that those Government servants who opted for sterilisation were granted one increment extra and were eligible to draw allowances on that amount;
- (b) whether it is a fact that the Fourth Pay Commission bas doubled the amount of Special Pay in all other cases, except that of Voluntary sterilisation cases;
- (c) if so, what steps Government have taken to remove the hardships caused to such Government servants; and
- (d) whether it would not affect adversely the family planning mea-- sores sponsored by Government?

THE MINISTER OF STATE IN THE DEPARTMENT OF EXPENDITURE IN THE MINISTRY OF FINANCE (SHRI R. K. GADHVI): (a) to (d) The Government employees who opt for sterilisation are granted 'personal pay equal to the amount of next increment due.

As the incentive granted to Government employees is in the nature of "personal pay and not 'special pay', the recommendations of the Fourth Central Pay Commission regarding special pay are not relevant in this regard.

The incentive of personal pay equal to. the amount of next increment due would continue to be available to Central Government employees who opt for sterilisation even in the revised scales of pay.

- (c) if so, what steps are being taken by Government to remove the disparity in order to see that a person in a higher scale may not draw less from the incumbent in a lower scale?

THE MINISTER OF STATE IN' THE DEPARTMENT OF EXPENDITURE IN THE MINISTRY OF FINANCE (SHRI B. K. GADHVI): (a) and (b) The position stated is correct except that revised scale is Rs. 1400—2600 and not Rs. 1400—2800.

(c) Initial fixation of pay of the two incumbents drawing pay in different pay scales, which are not comparable, is to be done under the provision of Central Civil Service (Revised Pay) Rules. 1986. There is thus no disparity involved.
