- (b) the number of times this super fast express train was stopped by chain pulling by miscreants during this period, year-wise:
- (c) whether any Member of Parliament made complaints about chain pulling frequently at Balarshah, Bhopal, Jhansi etc.:
- (d) whether any instructions have been issued to the concerned staff to run this train in time;
- (e) whether Government propose to attach permanent police post in Superfast trains to protect passengers of superfast trains from hooligans, if not, the reasons therefor; and
- (f) what other steps are being proposed in this regard?

THE MINISTER OF STATE OF THE MINISTRY OF RAILWAYS (SHRI MADHAVRAO SCINDIA):
(a) Kerala Express reached New Delhi late on 66 days in 1984, 79 days in 1985 and 56 days in 1986 (up to 31-10-1986).

- (b) This train was stopped on account of alarm chain pulling on 280 occasions in 1984, 290 occasions in 1985 and 200 occasions in 1986 (up to 31-10-1986).
  - (c) and (d) Yes, Sir.
- (e) No, Sir. Only G.E.P. escorts are provided on certain trains.
- (f) In order to prevent unauthorised alarm chain pulling/hose pipe disconnection, etc. by miscreants, surprise checks/raids are organised from time to time by the Railways in co-ordination with Government Railway Police. The matter is also brought to the notice of Police Authorities and the State Government concerned for taking necessary measures as law and order is State subject.

- (b) the names of places where such Dispensaries/Units have been opened during the said period:
  - (c) what are the reasons for not opening already sanctioned Unani Dispensaries/Units and by when these are likely to be opened; and
- (d) whether Parliament House Complex is also one of the places for which the Unani Unit had already been sanctioned but not yet opened; if so, the reasons therefor and by when the said sanctioned unit is likely to be opened?

THE MINISTER OF STATE IN THE DEPARTMENT OF HEALTH IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (KUMARI SAROJ KHAPARDE): (a) to Two Untni units have been sanctioned for C.G.H.S. Delhi during the last three years, out of which one has Disbeen established in C.G.H.S. other pensary Naraina Vihar. The Unit will be established wherever suitable accommodation is available. It has not so far been found possible to obtain any accommodation in the Parliament House Complex.
