

**Irregularities in the Selection Procedure in C.G.H.S.**

Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether it is a fact that educational qualifications of any candidate should be got verified/seen before issuing the interview letters to him;

(b) whether officers of C.G.H.S. administration are not aware of this condition, if so, what are the reasons therefor; and

(c) if the answer to part (b) be in negative, the reasons for raising objection on educational qualifications of the candidates who were issued letters for interview by C.G.H.S. during the year 1985 and even after conducting the interview and declaration of results in respect of post of Unani Pharmacists, and by when these candidates are likely to be appointed by the C.G.H.S.?

THE MINISTER OF STATE IN THE DEPARTMENT OF HEALTH IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (KUMARI SAROJ KHAPARDE): (a) to (c) The interview letters are issued to the candidates sponsored by Employment Exchange to whom the eligibility conditions are intimated at the time of placing the requisition. The educational qualification are verified from the Original Certificate at the time of interview. If any controversy arises regarding the Educational Qualification of any candidate, clarification is obtained from the appropriate authority even if the candidate is considered fit otherwise. The candidate is appointed only if he possesses the requisite qualifications.
