(a) what is the existing policy and procedure with regard to the recruitment of police personnel in Delhi stating whether any percentage is reserved for the candidates belonging to the Scheduled Castes|Scheduled Tribes and other weaker sections;

(b) when was the recruitment of police personnel made last;

(c) what is the number of persons selected out of the total number of candidates stating the mode of selection and to what extent the percentage of reservation was adhered to; and

(d) how many persons were selected on the basis of written test/examination, if any, held by the police authorities and what is the number of persons who were selected direct stating the reasons therefor

THE MINISTER OF STATE IN THE MINISTRY OF PERSONNEL, PUBLIC GRIEVANCES AND PENSIONS AND MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI P. CHIDAMBARAM); (a) As provided in Delhi Police (Appointment and Recruitment) Rules, 1980 and Standing Orders made thereunder, recruitment in various ranks in Delhi Police is made
