ORAL ANSWERS TO QUESTIONS

उत्तर प्रदेश सरकार द्वारा रक्षा कवचीं (बुलेटप्रूफ जाकिट) के ब्रायात की अनुमति का मांगा जाना

*341. श्री शरद यादव: क्या गृह संत्री यह बताने की कृपाकरेंगे कि:

(क) क्या यह सच है कि उत्तर प्रदेश सरकार ने हाल में विदेशों से रक्षा कथचों (बुलेट-प्रफूफ जाकिट) का आयात करने की अनुमति मांगी है; और

(ख) यदि हां, तो कितने रक्षा कवच मंगाने की अनुभति सांगी गयी है और प्रत्येक रक्षा कवच के लिये कितनी विदेशो मुद्रा अदा किये जाने की संभावना है?

कामिक लोक शिकायत तथा पेंशन मंत्राजय में राज्य मंत्री तथा गृह मद्रालय में राज्य मत्री (श्री पी॰ चिदम्बरम) : (क) और (ख) समी राज्यों ग्रीर संघ गासित क्षेत्र प्रशासनों से ग्रत्यन्त खतरनाक इयुटियों पर तैनात उनके पुलिस कार्मिकों के लिये बुलट-प्रुफ जैकेटों की न्यनाम आवश्यकता को बताने के लिए कहा गया था । अब तक प्राप्त मांगों (उत्तर प्रदेश से प्राप्त मांग सहित) के आधार पर बुलेट-प्रूफ जैकटों का प्रायात करने के लिए कार्यवाई की जा रही है। उत्तर प्रदेश के लिए निर्घारित जैकेटों की संख्या बताना जनहित में नहीं होगा ।

प्रत्येक जैकेट के लिए दी जाने वाली विदेशी मुद्रा की राशि, जैकेटों के आकार, किस्म और अन्य विशिष्टताओं के अनुसार अलग-अलग होगी । अतः इसमें लगने वाली विदेशी मुद्रा की राशि, वताना, इस स्तर पर संभव नहीं होगा ।

SHRI BUTA SINGH; Sir, it is again an opinion expressed by the hon. Member. (Interruptions).

SHRI K. MOHANAN; Sir, it fc not an opinion. He has asked a specific question. (Interruptions).

MR. CHAIRMAN: No, no. I will get the answer for you.

SHRI BUTA SINGH: Sir, the Government is committed to protect the We 'and property of the People not only in Pun-job—in Punjab it is a special task—but all over the country, we are committed to it

that we will protect he peoples' life and property. (Interruption).

SHRI K. MOHANAN. But you have failed...

SHRI V. GOPALSAMY: Mr. Chairman, Sir, while I appreciate very much the ever vigilant efforts of the Government to give maximum security to our WIPs by getting these bullet-proof jackets, may I know from the hon. Minister whether the Government will try t_0 get bulletproof pants also? If so, I would like to know whether the bullet-proof pants $_{an}$ d the bullet-proof jackets which they are already going to purchase, will be covered by khadi cloth or polyester cloth.

SHR1 K. MOHANAN: Bullet-proof helmets also.

SHRI P. CHIDAMBARAM: Sir, the hon. Member, with great respect to him, has not read the answer. These bulletproof jackets are being got ready for police personnel deployed on high-risk duties knd not for WIPs.

SHRI V. GOPALSAMY; The U. P. Government has asked for WIPs.

MR. CHAIRMAN: The thrust of the question is not whether you will provide bullet-proof jackets only but whether you will also provide bullet-proof pants.

SHRI K. MOHANAN: And helmets also.

SHRI P. CHIDAMBARAM; I sincerely hope that hon. Members are not ridiculing the idea...

SHRI V. GOPALSAMY: I am not ridiculing. 1 am very serious in my question.

SHRI RAHV GANDHI. - Sir, if I may interrupt, I -appreciate very much the worries of the hon. Member and I will definitely ask the Home Ministry to get bullet-proof pants made for the hon. Member.

SHRI K. MOHANAN: It % not necessary for Mr. Gopalsamy. It is necessary for you.

SHRI ATAL BIHARI VAJPAYEE; What will he do with pants, without a jacket?

SHRI RAJIV GANDHI; It may preserve his chastity.

SHRI GHULAM RASOOL MATTO: But who who take care of his head?

MR. CHAIRMAN; Mr. Bir Bhadra Pratap Singh.

SHRI BIR **BHADRA PRATAP** SINGH: Mr. chairman, Sir, the magnitude of the problem could not be minimised, and wee must not look to Punjab only. A situation has arisen in the Tami region whic'n is a miniature Punjab. Since parti tion up till now, Rai Sikhs have settled in the Tarai region and have taken it over. Now reports come that a lot of terrorists are hiding themselves in the Tarai region. I can assure you that even after Mrs. Gandhi's assassination, except in Kanpur, there was complete calm and quiet m U. P. and rehabilitation work was also done very well in Kanpur. Therefore, under those circumstances, may I know from the hon. Minister—the situation is not so light; certain conditions are there

MR. CHAIRMAN; Question please.

SHRI BIR BHADRA PRATAP SINGH; We have to be vigilant. Therefore, I would like to ask the hon. Minister; will he take more precautions and keep more vigilance so that no fight between Sikhs 'and Hindus may take Place in that region?

MR. CHAIRMAN: Yes, he will always te vigilant. Mr. Gurupadaswamy.

SHRI M. S. GURUPADASWAMY: I would like to know whether any rough assessment has been made in regard to the requirements for these bullet-proof jackets in the country as a whole 'and whether information has been secured by the Centre from various State Governments.

SHRI P. CHIDAMBARAM- We have, Sir.

SHRI P. BABUL REDDY: Sir, I certainly appreciate that the security of the

State should be given top priority, but there must be an attempt to give as much information as possible, steering clear of security. What is the security involved.

MR. CHAIRMAN; No, no...

SHRI P. BABUL REDDY: Please permit my question.

MR. CHAIRMAN: All right. Put the question now.

SHRI p. BABUL REDDY; About the cost involved, the answer given is that it depends upon the size of the jacket, etc. If he cannot say about the average size, can he tell us the minimum and the maximum of the price? Is any security

involved in the price? I am questioning that. Whether it is one thousand rupees

or ten thousand rupees, is the security of the state involved in that?

MR. CHAIRMAN: You have not read the question. Please read part (b) of the question, which says:

"If so, what is the number of bulletproof jackets for which permission has been sought 'and the amount of foreign exchange likely to be paid for each jacket?"

 S_0 the supplementary is not relevant.

SHRI P. BABUL REDDY: Sir, yon please read the answer.

MR. CHAIRMAN: Please read the answer (*Interruptions*). Please read the answer.

SHRI NIRMAL CHATTERJEE: Why can't the Minister give the answer?

MR. CHAIRMAN: I will read the answer. The amount of foreign exchange likely to be paid for these jackets depends on various factors. The answer is relevant.

SHRI P. BABUL REDDY; You are there to project us. Kindly permit me to speak for half a minute.

MR. CHAIRMAN: Half a minute permitted

SHRI P. BABUL REDDY; The answer is that the price of these jackets de-

pends upon their size. I am asking the average 1price.

MR. CHAIRMAN: You are one of the responsible Members. I am very careful in reading the papers. Before i come, I read the questions and the answers. It is clearly stated that "the amount of Foreign Exchange likely to be paid for each jacket would vary according to its size, quality and other specifications. The question is about the 'amount of foreign exchange involved in this. The question has been put in that way.

SHRI P. BABUL REDDY; The answer is for each jacket.

MR. CHAIRMAN: No. No. My decision is final.

SHRI P. CHIDAMBARAM: As I said, the amount of foreign exchange will depend ^e size, quality and offiier specifications. We have just called for tenders. We are examining the quotations. At this stage, it would not be possible for me to give the amount of foreign exchange that would be involved.

MR. CHAIRMAN: Mr. Motiram Patel. If the Members repeat the question, I will go on to the next question.

SHRI VITHALBHAI MOTIRAM PATEL: Mr. Chairman, Sir, may I know from the hon. Minister whether any inquiry has s been made to find out if the bullet-proof jackets can be made in India?

SHRI P. CHIDAMBARAM; We have examined this question. The material required for making such jackets is no t available in India.

SARDAR JAGJIT SINGH AURORA: Sir, I would like to know whether suffi

cient consideration has been given to the fact that good training may obviate tile need for so many jackets. My suggestion is that considering the number involved, we should try t_0 produce them in the country.

SHRI P CHIDAMBARAM: I agree with the suggestion. We shall certainly try to do.

SHRI SATYA PAL MALIK; *

MR. CHAIRMAN: Irrelevant. Not relevant. The question is disallowed Mr. Jagesh Desai. (Interruptions). When the Chair is on its legs, every Member must sit down. I have said that the question is disallowed. All these things are unnecessary. You did not hear me. What am I to do? That question has been disallowed by me. Mr. Jagesh Desai. That will not igo on record. (Interruptions).

SHRI ATAL BIHARI VAJPAYEE: Sir, what about the 'allegations made in his question? (Interruptions).

MR. CHAIRMAN; It will not go on record. Now, Mr. Jagesh Desai.

SHRI ATAL BIHARI VAJPAYEE; AH right.

SHRI JAGESH DESAI: Sir, the honourable Minister just now said that in public interest he would not disclose the number of jackets to be given to the States. Secondly, he also says that the size and other things are not known and so, they are not able to give the details of the amount of foreign exchange involved. My point is that once you give the amount of foreign exchange, whatever may be the figure, you can arrive at the number of jackets to be imported and, therefore, I would like to know whether, when you disclose the amount of foreign exchange involved and you do not disclose the number of jackets, it would De in public interest, Is it in public interest to disclose the amount of foreign exchange involved?

MR. CHAIRMAN: You need not support the Minister. Now, tSie next Question. Question No. 342. Mr. ram Awadesh Singh.
