THE MINISTER OF STATE IN THE AFFAIRS HOME OF MINISTRY (SHRI CHINTAMANI PANIGRAHI) Government's (a) and (b) Central Scheme of Pension to freedom fighters namely 'Swatantrata Samık Samman Pension Scheme' is applicable to both eligible Territories and the Union freedom fighters are given pension In the Union Territory of Goa, Daman and Diu there is another pension scheme namely Goa, Daman and Diu Freedom Fighters Welfare Rules under which pension is given to freedom fighters This Scheme has further been liberalised in May, 1986.

- (b) to what uses these stations are being put, and

(c) what are the details of plans to establish more earth stations and the time-targets for the same?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI SANTOSH MOHAN DEV) (a) Satellate Earth stations at following places in the country have been established so far for domestic satellite communication -

- (1) 29 earth stations have been set up by Department of Telecom Delhi, Bombay Calcutta Madras Shillong, Jalandhar, Jaipur, Lucknow Patna Ahmedabad, Hyderabad Ernakulam, Bhubneshwar, Air wal, Imphal Itanagar Agartala, Gangtok, Port Blair, Car Nicobar, Kavaratty, Mini Coy, Bhuj, Panjim, Jodhpur, Srinagar, Leh & Kulu
- (11) Five earth stations have been set up for public sector undertakings at urban & Offshore station (ONGC), Manakpur & Bangalore (ITI) and Vijaipur (NFL) Two earth stations have been set up by Videsh Sanchar Nigam Ltd for international satellite communication. Arvi (Pune) and (ii) Lachiwala (Dehradun)
- (b) These stations are being used for providing national and tional long distance trunk telephone connections as well as national and internationa liteevision coverage satellite.
- have (c) Following plans drawn up to establish additional earth stations in the country in the 7th Plan
 - sta~ (1) 10 Transportable earth tions
 - (n) 18 earth stations in the ra mote backward and hilly areas of the country.

THE MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI Z. R ANSARI): (a) Yes, Sir.

(b) 2750 sq km. of the forest area in Mayurbhanj District of Orissa has been established as Similipal Tiger Reserve This area is receiving Central Assistance for the preservation of the flora and fauna under the Centrally Sponsored Scheme Project Tiger, and has received from the Central Government Rs. 63.16 lacs during the Sixth and Seventh Five Year Plans.

- (e) if so what are the reasons for delay and by when this exchange is likely to start functioning?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI SANTOSH MOHAN DEV): (a) The number of automatic and electronic exchanges sanctioned during 1986-87 is 15 and 5 respectively.

- (b) The information is given in the enclosed Statement (See below).
- (c) The remaining exchanges are likely to start functioning by March 1988 subject to availability of stores and material.
 - (d) Yes, Sir.
- (e) The delay is due to non-availability of equipment. In anticipation of receipt of equipment, building work had commenced. The exchange is likely to start functioning by the first quarter of 1988.
