THE MINISTER OF STATE IN THE DEPARTMENT OF DEFENCE RESEARCH AND DEVELOPMENT IN THE MINISTRY OF DEFENCE (SHRI ARUN SINGH) (a) Government have approved the establishment of a Naval Base of Karwar in Karnataka State at a cost of approximately Rs 350 crores in the first phase

(b) The project includes construction of Naval airfield. The construction of railway line is not a part of the project. However, the Railway Board has been approached to work out the various alternatives to link Karwar by rail and to intimate cost estimates and time-frames

THE MINISTER OF STATE IN THE DEPARTMENT OF DEFENCE PRODUCTION AND SUPPLIES IN THE MINISTRY OF DEFENCE (SHRI SHIVRAJ PATIL) (a) and (b) Mazagaon Dock Ltd. is one of the Yards for indigenous construction of frigates and sub-marines. Details of manufacturing programme cannot be disclosed in public interest. Delivery of first sub-marine built in India is expected in the beginning of the next five-year plan.
