Fall in growth rate

(a) what are the reasons for a fall in growth rate of economy in the year 1985-86; and

(by what measures have been taken by Government to improve the position as targeted in the Seventh Five Year Plan?

THE MINISTER OF STATE IN THE MINISTRY OF PLANNING (SHRI SUKH RAM) (a) and (b) There was no fall in the growth rate of economy as a whole, in 1985-86 as compared to 1984-85. As per the Annual Plan 1986-87 (copies of which have been laid on the Table of the two Houses of Parliament), the Gross Domestic Product in real terms is estimated to have gone up by over 4.5 per cent in 1985-86 as against 3.7 per cent in 1984-85

Despite unfavourable monsoon, agricultural production in 1985-86 is estimated to have been higher than in 1984-85. The total production of food-grains in 1985-86 is estimated at 150.5 million tonnes as against 146.2 million tonnes in 1984-85. Sugarcane production is estimated to have increased from 173.57 million tonnes in 1984-85 to 175.0 million tonnes in 1985-86. Cotton from 8.47 million bales to 8.60 million bales and Jute/Mesta from 7.98 million bales to 12.40 million bales during the same period

The provisional index of industrial production for 1985-86 shows an increase of 6.2 per cent over 1984-85. Though it is lower than the Plan target of 7 per cent, it is significant to note that the industrial growth has been steadily rising since 1983-84. The Manufacturing sector recorded a growth rate of 5.8 per cent in 1985-86, Electricity generation of 8.6 per cent and Mining 4.6 per cent. There was also a substantial augmentation of infrastructural facilities during 1985-86

With the launching of the Seventh Five Year Plan in 1985-86, certain major policy initiatives were taken to promote growth reinforce anti-poverty programmes and give a new direction to fiscal policy. As a result of these policy initiatives and vigorous implementation of development programmes
