- (a) whether Government have received complaints of poor visibility of Television at Jamnagar;
- (b) whether it is a fact that both the Television relay stations at Rajkot and Dwarka are unable to give proper coverage to Jamnagar due to the distance, as a result of which the people of Jamnagar are being deprived of important educational and information programmes,
- (c) whether Government have received requests from some organisations for setting up a new television relay station at Jamnagar, if so, what are the names of those organisations and Government's response to the requests, and
- (d) by when Jamnagar is likely to get a television relay station?

THE MINISTER OF STATE OF THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI AJIT PANJA)
(a) Yes, Sir.

(b) TV reception at Jamnagar, which falls on the fringe of the coverage zone

of the existing high power (10 KW) TV transmitter at Rajkot, has improved consequent on repairs to the antenna system of the TV transmitter, Rajkot. However, the existing high power (10 KW) TV transmitter at Dwarka is not expected to provide service to Jamnagar.

- (c) Requests have been received from various organisations. 1 e., TV Viewers Umion, Jamnagar Navangar Chamber of Commerce and Industry, Jamnagar and individuals from time to time for setting up of a TV transmitter at Jamnagar. Constraint of resources does not, however, permit the setting up of a new TV transmitter at Jamnagar during the VII Plan period.
- (d) TV service in the country can be expanded only in a phased manner. As such, provision of 'a TV transmitter at Jamnagar will depend on the future availability of resources for this purpose.
