## Stitching of foodgrain bags

2483. SHRI SANTOSH BAGRODIA: Will the Minister of FOOD AND CIVIL SUPPLIES be pleased to state:

- (a) whether it is a fact that the Food Corporation of India has not made it compulsory for keeping machine stitched bags for all kinds of foodgrains at the procurement centres;
  - (b) if so, the reasons therefor; and
- (c) what action Government propose to take in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD AND CIVIL SUPPLIES (SHRI GHULAM NABI AZAD):
(a) to (c) Machine stitching of bags for foodgrains has not been made compulsory due to absence of legal provision, and the administrative difficulties involved. However, to encourage machine stitching of bags voluntarily, an incentive of 40 paise per bag is being provided by the Government of India.

THE MINISTER OF STATE IN THE DEPARTMENT OF AGRICULTURE AND COOPERATION IN THE MINIS-TRY OF AGRICULTURE YOGENDRA MAKWANA); (a) and (b) State-wise details of Central assistance sought by various States for drought and flood etc., and ceilings of expenditure approved by the Government of India during the years 1983-84 to 1986-87 are given in statements I and II respectively [See Appendix CXL, Annexure No. 957. Statements indicating the dates of receipt of Memoranda and approval of ceilings of expenditure during 1986-87 for drought and floods, etc. are given vide statement III and IV respectively [See appendix CXL, Annexure No. 96].

Some States like Andhra Pradesh, Keraia and Himachal Pradesh have represented about the inadequacy of ceiling of expenditure approved for relief measures during 1986-87.
