THE MINISTER OF WATER RE-SOURCES (SHRI B. SHANKARANAND): (a) to (e) Sardar Sarovar Project has been found acceptable by the Technical Advisory Committees of the Planning Commission and is pending clearance from environmental and forest angle. Meanwhile construction of canal and foundation work or dam are in progress. The expenditure incurred till September 1986. is Rs. 355 crores. The commitment charges are borne by Government of India and Government of Gujarat are not required to make any payment on this account. The increase in cost of a project is due to many factors including price increase de to delay. It is difficult to estimate the increase in cost due to delay in implementation.

THE MINISTER OF STATE IN THE DEPARTMENT OF FERTILIZER IN THE MINISTRY OF AGRICULTURE (SHRT R. PRABHU): (a) and (b) Urea technology of Snamprogetti was selected i, n 1979 after a global evaluation by an

- Expert Group. Accordingly, consultancy services of Snamprogetti have been utilised for the Thai Project of Rashtriya Chemicals & Fertilisers Ltd., Hazira project of KRIBHCO (both Vi Plan projects), Guna project of National Fertilizers Limited, Aonla project of IFFCO and Jadishpur project of Indo-Gulf Fertilizers & Chemicals Corporation Ltd. (VII Plan projects).
- (c) The State Governments are being advised regularly t_0 promote the use of organic manures alongwith chemica] fe-ti-lizers. As a result of these efforts, it is estimated that about 241. 7 million tonnes of compost were utilised in 1985-86 to supplement the use of chemical fertilizers.

The membership of such members for allotment of plot/flat who have acquired foreign nationality is not considered by the Administration.
