## REFERENCE TO THE NEED TO ES-TABLISH A VANASPTI PLANT AT **BALASORE IN ORISSA**

SHRI BASUDEB MOHAPATRA (Orissa): Madam Deputy Chairman, I draw the attention of the Government through you for establishment of a vanaspati plant at Balasore in the State of Orissa. The State Government has taken the initiative to set up this plant in Balasore District which is known as nonindustry district in the State. The total cost of this plant would be about Rs. 6 crores. The project report was prepared and submitted to the N. C. D. C. C. for approval. After establishment of this project, it will rehabilitate the displaced persons of defence project to be situated at Baliapal.

The Ministry of Food and Civil Supplies (has to issue the letter of intent which is awaited. Importance has been attached to the project only due to taking up of the rehabilitation schemes. The local people are anxiously waiting to see that this plant would accommodate most of the displaced personnel.

The N. C. D. C. should give top priority in sanctioning the project. In spite of several remiders issued by the State Government, no action has heen taken by the N. C. D. C. to accord approval.

I would request the Government to instruct the N. C. D. C. to be liberal in sanctioning the project and to see that the vanaspati plant is established as early as possible. Thank you, Madam
