REFERENCE TO THE NEED TO ESTABLISH A FISHING HARBOUR AT PARADEEP AND GOPALPUR IN ORISSA

SHRI BASUDEB MOHAPATRA (Orissa): I draw the attention of the Government through you to a specific problem of the State of Orissa i.e. the establishment of two fishing harbours at Paradeep and Gopalpur in the State.

You know, Madam, Orissa has got a vast coastal belt covering about 485 kilometres. As such the State has abundant marine fisheries resources. The State Government has taken up several projects with intention to contribute substantially to the socioeconomic conditions of the poor fishermen of the State. The country earns a huge amount of foreign exchange by exporting fish produced from Orissa.

During the Seventh Plan period, emphasis has been laid to develop marine fish production which would be raised from 45,000 metric tonnes in 1984-85 to one lakh metric tonnes. It is proposed to provide infrastructural facilities by way of construction of fishing harbours in coastal belt of the state, Some of the projects are

to be taken up with the assistance of foreign countries and other projects like Paradeep and Gopalpur are included in the Central sector.

At the instance of the Government of India the Central Institute of Coastal Engineering for Fisheries prepared a project report for fishing harbour at Gopalpur with an estimated cost of Rs. 599 lakhs and submitted it to the Government for sanction.

For the establishment of fishing harbour at Paradeep, the construction of a separate harbour for small mechanised vessels and also berthing facilities for deep-sea vessels are proposed to be constructed with one hundred per cent assistance. A combined project report for the construction of a deep-sea trawler berth at a cost of Rs. 424.50 lakhs inside the commercial harbour and a fishing harbour for small mechanised boats at a cost of Rs. 1890.57 lakhs at Mahanadi river mouth has been submitted to Government for approval. The State Government has requested several times to the Central Government for approval.

A sum of Rs. 30 crores is required to implement these projects. Since it has been included in the Central sector, I would request the Government to provide the required amount to the State Government for establishment of fishing harbour at Paradeep and Gopalpur in the State of Orissa as early as possible.
