It expressed appreciation for the establishment of the Independent Commission of the South for development issues.

(d) India is consulting and co-ordinating closely with other Non-aligned countries for the effective implementation of these decisions.

(b) A Show Cause Notice dated 15-1-1986 has been issued to M/s. Kirloskar Brothers Limited, M/s. Kirloskar Proprietary Limited and Directors/Executives of the aforesaid companies. The adjudication proceedings are in progress. Simultaneously criminal proceedings have also been initiated against these two companies and Directors/Executives of both the companies before the Court of Chief Judicial Magistrate Class I Pune.
