Towns with a population of around 20,000 and above and offering potential for economically viable marketing of LPG are being taken up in a phased manner.

- (d) So far drilling has been taken up at 165 places|structures in Cambay basin. Ten more places have been identified for drilling in future.

Scrapping of Oil Selection Boards
