- (xi) Pickets have been posted at the strategic points.
- (xii) The intelligence system has been strengthened.
- (xiii) Surprise checking of vehicles is being carried out to detect those involved in commission of crime.

the craft teachers in Grih Kalyan
Kendra managed by the Ministry of
Personnel, Public Grievances and
Pensions is Rs. 491/-p.m.

(b) Appointments in the Grih Kalyan Kendra are not appointments to regular jobs under Government. It is work for which an honorarium is paid. For the purpose of appointment only the dependents of low paid and needy Central Government employees are considered and they are paid a

monthly honorarium calculated on the basis of minimum wages prescribed by the Delhi Administration. This is in conformity with the objectives of the Grih Kalyan Kendra which is to provide to the dependents of Central Government employees some experience for improving their career prospects elsewhere as also to supplement the income of the family for the time being. The employees of the Grih Kalyan Kendra are also free to get themselves registered with the employment exchanges to find jobs elsewhere.

- (c) Employees of GKK are not treated as Central Government employees. However, many employees of GKK enjoy certain facilities like medical treatment by virtue of their being dependents of Central Government employees.
