Ad-hoc employees in the Engineering Department and D.G. Doordarshan, New Delhi.

- 1513. SHRI F.M. KHAN: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:
- (a) the number of ad-hoc employees category-wise working for three to four years in the Engineering Department of Doordarshan in the Lok Nayak Bhavan, and Directorate General Doordarshan, Mandi House, New Delhi and who have not been regularised so far;
- (b) the number of class I and II appointments made during the ban period; and
- (c) by what date these *ad-hoc* employees are likely to be regulariesd and, the reasons therefor?

THE MINISTER OF STATE OF THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI V. N. GADGIL): (a) Only one employee has been working on *ad-hoc* basis for over three years as a Peon (Group D) in the Directorate General, Doordarshan in Lok Nayak Bhavan and Mandi House.

- (c) The *ad-hoc* employee will be appointed on regular basis as and when a regular vacancy of Pern becomes available.

Substandard DDA flats in Ashok Vihar, New Delhi

1514. SHRI KRISHNA KUMAR BIRLA : DR. BAPU KALDATE :

Will the Minister of URBAN DE-VELOPMENT be pleased to state :

(a) whe'her it is a fact that over 200 L1G and MIG flats constructed

- by DDA in Ashok Vihar's Phase III, Pocket B are crumbling down because of the substandard material used in their construction;
- (b) whether Government have made any inquiry into the construction of these fiats to fix responsibility; and
- (c) if so, what are the details thereof stating the action taken/proposed to be taken against the DDA officials/ contractors involved in the construction of sub-standard flats and the steps Government propose to take to rectify the defects in these flats?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT (SHRI DALBIR SINGH): (a) DDA has reported that no case of crumbling down of the LIG/MIG flats has been reported.

- (b) Yes, Sir. Quality control unit of DDA has inspected the flats three times.
- (c) While the observations of Chief Engineer (Quality Control) are under examination, most of the defects pointed out by him have been rectified.
