1433. SHRI PRABHAKAR RAO KALVALA: Will the Minister of INFORMATION AND BROAD-CASTING be pleased to state:

- (a) whether any instances have come to Government's notice of absentee casual artists(s)/news reader(s)/translator(s) of the News Service Division, All India Radio, New Delhi obtaining payment of fees by manipulating false certificates of attendence:
- (b) whether it is a fact that some official of the News Services Division, All India Radio, New Delhi have been trying to destroy the incriminating material related to such cases, in a bid to hush up the matter; and
- (c) what steps have so far been taken by his Ministry to ensure safe custody of the relevant material to facilitate an impartial enquiry into the matter?

THE MINISTER OF STATE OF THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI V.N. GADGIL): (a) A complaint alleging payment to a casual Artist said to have been absent on a particular day in 1982-83 has been received.

- (b) No, Sir.
- (c) The Government records always remain in safe custody.

Deducting of income tax at source from casual artists of AIR

- 1434. SHRI PRABHAKAR RAO KALVALA: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:
- (a) whether it is a fact that some casual artists (news readers/translators) of the News Service Division, All India Radio, had been getting

- (b) whether it is a fact that the total amount of fees paid to each of the said artists in a single year was subject to deduction of income-tax at source; and
- (c) whether any income tax was deducted at source from this category of artist during the last three years?

THE MINISTER OF STATE OF THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI V. N. GADGIL): (a) No, Sir.

(b) and (c) Income Tax deductions are made only in respect of regular employees; no deduction has been made in respect of Casual Assignees.

## Allotment of Type III quarters in Kalibari Marg, New Delhi

- (a) whether it is a fact that a large number of Type III quarters are ready for allotment in Kalibari Marg, New Delhi for the last few months; and

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT (SHRI DALBIR SINGH): (a) 90 type III quarters at Kalibari Marg have been completed on 31-3-86.

(b) The quarters will be handed over to the Directorate of Estates for allotment as soon as completion certificate, electric load and water connection is sanctioned by NDMC.

#### Illegal sale/construction of houses in Ashok Nagar, Delhi

(c) DDA has lodged FIRs with the Police Station, Special Cell under Sections 3 and 4 of DIRT Act.
