Newsprint Production

40. SHRI M. KADHARSHA:

SHRIMATI SUDHA VIJAY JOSHI:

Will the Minister of INDUSTRY be pleased to state:

- (a) the total production of newsprint in the country at present both in private and public sector;
- (b) the estimated demand thereof, State-wse and language-wise; and
- (c) by when Government hope to achieve self-sufficiency in the production of newsprint?

THE MINISTER OF STATE IN THE DEPARTMENT OF INDUSTRIAL DEVELOPMENT (SHRI M. ARUNACHALAM): (a) The production of newsprint in the country during the year 1985-86 is estimated at 2.70 lakh tonnes.

- (b) The demand for newsprint which was about 3.85 lakh tonnes during 1984-85 is expected to rise to 5 lakh tonnes by 1989-90. There is no system of quantifying the demand for newsprint State-wise or language-wise.
- (c) In addition to the present installed capacity of 2.80 lakh tonnes, an additional capacity of 6.36 lakh tonnes has been approved by way of Industrial Licences/Letters of Intent. The approved capacity is under various stages of implementation.

अौद्योगिक विकास विभाग में राज्य मंत्री (श्री एम. अरुणाचलम): (क) वर्ष 1985-86 में सीमेंट का उत्पादन 331 लाख मी. टन था। नेशनल काँसिल फार सीमेंट एण्ड बिल्डिंग मैटिरियल्स तथा पटसन आयकत द्वारा लगाए गए अनुमानों के अनुसार रिसाव के कारण अनुमानत: 1 मे 1.2 प्रतिशत तक सीमेंट बर्बाद हो जाता है। मूल्य के अनुसार यह हानि: 40 करोड़ रुपये मे 45 करोड़ रुपये तक की हो सकती है।

- (स) रसने-उठाने आदि के दौरान जां सीमोंट की वर्बादी होती है उसे न्यूनतम करने के लिए सरकार ने निम्निलियत कार्य किये है जिनसे काफी सफलता मिली है :——

Appointment one person as a Judge has been approved and is to be notified shortly. Matter of filling up the remaining vacancies is engaging the attention of the Government in consultation with the authorities prescribed in the Constitution.
