#### Mosquito menace in Delhi

1.90. SHRI GAYA CHAND BHU-YAN: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state whether Government are aware that mosquito menace has affected New Delhi and its suburban areas, if so, what preventive measures have been taken in this regard?

THE DEPUTY MINISTER IN THE DEPARTMENT OF FAMILY WEL-FARE (SHRI S. KRISHNA KUMAR): Increase of Mosquito population during March-April is a natural phenomenon. Anti-larval measures at weekly intervals using mosquito larvicidals oil, Fenthion, Ternephos, parisgreen alongwith the deployment of Larvivorous fish and minor engineering measures to reduce the source of mosquito breeding are being carried out. The rural areas of Delhi as well as Jugghi-Jhopries in urban areas and labour huts in the neighbourhood of the construction projects are spraying with three rounds of BHC in a year.
