1986 in North and the North-eastern Railways and the number of those belonging to the Scheduled Castes and Scheduled Tribes amongst them; and

(c) After how many years' service they are made permanent?

MINISTER OF THE TRANSPORT BANSI LAL): (a) Regular appointment of Doctors in the Railways is made through examination!selection conducted by Union Public Service Commission. However, the General Managers on the Railways have been authorised to appoint Doctors with the minimum qualifications of M.B.B.S, and within the maimum age limit of 30 years' on adhoc basis as a stop-gap arrangement till the Union Public Service Commission selected Doctors become available to replace them.

- (b) 55 including 4 Scheduled Caste and 28 including 2 Scheduled Cast<sub>e</sub> Doctors were appointed on *ad-hoc* basis during the period March, 1983 to March 1986 on Northern and North ■Eastern Raiways respectively. No Scheduled Tribe *ad-lvoc* Doctors were appointed on these two Railways during this period.
- (c) These Doctors can acquire permanent or regular status only when they get selected in the Combined Medical Services Examination or Special Selection conducted by Union Public Service Commission from time  $^{\rm f}$ .0 time.

## Educational Institutions in North and North-Eastern Railways

- 151. SHRI SOHAN LAL DHUSIYA: Will the Minister of TRANSPORT be pleased to state:
- (a) the number of high school and intermediate colleges for boys and girls run by railways in North and North Eastern Railways;
- (b) what is the total number of teachers in high school 'and inter colleges belonging to Scheduled Castes, Scheduled Tribes and other communities;
- (c) whether the policy of reservation in services for the Scheduled Caste<sub>s</sub> and

Scheduled Tribe<sub>s</sub> k strictly observed at the tim<sub>e 0</sub>f recruitment for the above institutions, if not, the reason<sub>s</sub> therefor, and

(d) What are the minimum requisite qualifications of teachers who are recruited for the above schools and colleges?

THE MINISTER OF TRANSPORT (SHRI BANSI LAL): (a) One High School, One Intermediate College, One Higher Secondary School in Northern and 4 Intermediate Colleges in North-Eastern Railawys.

## Destruction of Research work in the Jawaharlal Nehru University

- 152. SHRI KRISHNA KUMAR BIR-LA: Will the Minister of HUMAN RE-SOURCE DEVELOPMENT be pleased to state:
- (a) whether it is a fact that due to the callousness of the Jawaharlal Nehru University Authorities, many valuable research work which was accomplished after years of efforts by the scholars is being destroyed by termites;
- (b) if so, what are the details thereof; and
- (c) what action Government propose to take in this regard?

THE MINISTER OF STATE IN THE DEPARTMENT OF EDUCATION AND CULTURE (SHRIMATI SUSHILA ROHATGI): (a) to (c) According  $t_0$  the information furnished by the Jawaharlal Nehru University, no research work has been destroyed. However on account of seepage in walls, soe damage was caused to 12 M. Phil dissertations and 4 Ph.D. thesis, which were stored in built-in-cupboard. Additional copies of these documents are available with the University

The University has provided alternate storage facilities for the research papers. Steps have also been taken to control pests like termites  $t_0$  ensure safety of the papers and documents in the custody of the University.
