- (b) The MRTP Commission received 168 complaints during 1985 and disposed of 87 out of them.
- (c) It is not the function of the MRTP Commission to effect compromises between the contending parties. In three cases appeals were filed before the Supreme Court against the orders passed by the Commission.

The scope of specialised services to be obtained from this Joint Venture shall be defined and quantified in consultation with the Chief Executives of Public Sector Undertakings. The payment of fees etc. by the concerned undertakings will depend upon the scope of servkes to be rendered by the proposed company. Government have not signed any agreement with a non-resident Indian company in this behalf.
