Closure of coal m'.nes

505. SHRI SURAJ PRASAD:

SHRI INDRADEEP SINHA:

Will the Minister of ENERGY be pleased to state:

- (a) whether it is a fact that a large number of coal mines were closed after nationalisation of coal mines;
- (b) whether it is also a fact that as a result thereof a large number of labourers have been rendered unemployed;
- (c) whether it is a fact that there is a persistent demand to open these coal mines;
- (d) if so, what is the reaction of Government thereto?

THE MINISTER OF ENERGY (SHRI VASANT SATHE): (a) to (d) Since nationalisation a few mines have been closed. The reasons for the closure were exhaustion of coal reserves, adverse economics etc. However, no worker was rendered unemployed on this account.

Coal India Ltd. has initiated steps' for opening some of these closed mines having workable reserves through re-organisation schemes and formulation of new projects.

Converting petrol fuelled car inte Compressed natural gas run car

- (a) whether the O.N.G.C, has developed the technology for converting a conventional petrol fuelled car into compressed natural gas (C.N.C.) run car;

- (c) if so, by when it will be done and what are the details thereof?

THE MINISTER OF STAT3 OF THE OF PETROLEUM AND GAS (SHRI CHANDRA MINISTRY NATURAL SHEKHAR SINGH): (a) to (c) O.N.G.C, have experimented with the use of compressed Natural Gas in a Jeep by using an imported dual fuel conversion kit. The experiment has not reached the stage of commercial use.
