Inadequate safety measures in LPG cylinders

*93. DR. G. VIJAYA MOHAN REDDY: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to

- (a) the number of accidents which took place in the country during the year 1985-86 due to inadequate safety measures in the LPG cylinders and other appliances;
- (b) the measures being taken to evolve the improved quality of cylinder valves, and pressure regulators so as to minimise accidents; and
- (c) whether any proposals for import of latest technology are being considered for this purpose, if so, the details thereof?

THE MINISTER OF STATE OF THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI CHANDRA SHEKHAR SINGH): (a) to (c) A total number of 172 LPG accidents occurring for various reasons was reported in 1985-86. The investigation repoirts which the oil marketing companies send in each case to the Chief Controller of Ex-

plosives show that LPG accidents are generally caused due to ignition of escaped LPG mostly resulting from negligence or mishandling at the customer's premises of equipment like rubber hose, stove knob, pressure regulator etc. The oil marketing companies are procuring only ISI certified LPG cylinders, valves and regulators, while distributors are under instructions to release a new connection only on ensuring that the consumer has an ISI certified stove. All such ISI certified equipment has in-built safety characteristics.

Oil drilling at Theyur

spudded on 20-3-86 and has reached
a depth of 1401 mts on 17-4-86,
against a target depth of 3500 mts.

- (b) 23 wells have been drilled so far at 14 different places in onshore Cauvery Basin.
- (c) Oil/gas was discovered at Karaikal, Kovilkallapal and Narimanam besides minor hydrocarbon indications at Madnam and Tira-

varur. The cost of completed wells where accounts have been finalised ranges from Rs. 11 lakhs to Rs. 218 lakhs.

- (d) During 1986-87, it is proposed to drill 5 wells onland and 2 wells offshore in Cauvery Basin.
