- 642. SHRI ACHCHHEY LAL BALMIK: Will the Minister of FOOD and CIVIL SUPPLIES be pleased to state:
- (a) whether the Food Corporation of India discriminated in the matter of ad hoc revision of pay scales b<"'t ween regular Labourers of Delhi and Uttar Pradesh region and vio lated the principle of equal wages for equal work; and
- (b) whether any representation bas been received in ti is connection and if so, whether any steps have been taken to remove this discrimination?

THE MINISTER OF STATE IN THE MINISTRY OF PLANNING AND IN THE MINISTRY OF FOOD AND CIVIL SUPPLIES (SHRI AJIT PANJA): (a) The pay scales of departmental workers of Delhi and Uttar Pradesh are the same. There is, however, some difference in the rates of CCA and HRA which affects the total pay of the workers in the two Regions. The Management and the FCI Workers Union therefore mutually agreed to have a difference of Rs. 25/-at the time of grant of ad hoc interim increase in the wages ofthe, workers.

(b) Yes, Sir, The question of wage revision of workers is pending in the Supreme Court.

Import of beef tallow
