Mr. Deputy Chairman, Sir, the different States in our country continue to wage an internecine war against each other on the question of the sharing of river waters, the surplus waters of Eavi, particularly during the rainy season have played havoc in Punjab. The Pakistan Government has constructed various works on its territory opposite the Punjab villages to divert water to the Indian territory thereby cause floods here. Sir, this activity of Pakistan has continued despite various protests by the Government of India. And for counterprotaective measures, the Central

Government has in the past given certain assistance to the Punjab Government. Now again the Pakistan Government has constructed two spurs, two closure bunds and one cunette along the right side bank of river Ravi, with the resule that there were heavy floods in Punjab which caused a lot of damage to the property there.

Sir, I would take this opportunity to once again request, through you, the Central Government to provide sufficient assistance to the Punjab Government for taking certain counter-protective measures there. to raise certain constructions to avoid floods in the State of Punjab. I also request the Central Government to take up the matter with the Pakisan Government very strongly so the flood waters are not diverted from there to Punjab. Thank you.
