REFERENCE TO THE HEAVY LOSS OF LIFE AND PROPERTY DUE TO FLOODS IN ANDHRA PRADESH

SHRIMATI RENUKA CHOW-DHURY (Andhra Pradesh): Sir, thank you for giving me this opportunity. I want to draw the attention of the House to a very important issue, like the floods that have been happening in the State of Andhra Pradesh.

I have just come back from my State, where hundreds of thousands of people have lost their sources of livelihood, revenue and hope to re-cunerate them in the immediate future.

For 6 years, nature has played cruel trick with the State of Andhra Pradesh. We were starved of water, people longed for a drop of water and the land got depleted. Every day the level of water was dropping. And suddenly the skies opened. Today hundred of thousands of women and children are marooned, stranded and left desolate in places because of this deluge of water that has come in

Sir, I urge the whole nation to look upon these natural calamities as oart of their own responsibilities and come forward to make it possible for the State to help each other out, overcoming trivialities and

other problems that seem to hamper each other under certain circumstances. The Central Government must not only execute it in terms of money and other resources, but we will have to consider what is going to happen after the floods are over when water recedes and havoc is left behind. People must come forward in a spirit of brotherhood and sisterhood and render all help so that the people recuperate and rehabilitate themselves. There will be an outbreak of epidemics. We want the media to come forward and help us in advertising to the people, to reach the message to them We need the AIR.

We need time on the Doordarshan for the state so that we can also warn people about what is going to happen in other States. It is with this that we must have consideration, planning and anticipation. That is the reason why the state Government has been pressing for execution of the various Projects in anticipation of such needs. Though we were under drought for six years, we realised that floods could come and affect us in an adverse fashion as it has done today. That is why projects like Kolavaram and others must be hastened so that next time we are able to harness excess water, valuable water which can be used in a correct way for irrigation and for implementation of other programmes which will be progressive for humanity and not as an instrument against the human beings. So, I urge the House, all of them to associate themselves with me at this moment. Coming from the State of A.P. we must anticipate natural calamities like these and rise above our petty differences and work towards good implementation of programmes so that we can harness natural calamities and not become victims of them, Sir.
