wide variety of programme requirements for various sections of viewers are accommodated. Therefore, it is not considered feasible to include 'Sansad Samachar' and "Parliament News" in the National Programme of Doordarshan.

- (a) whether in May 1985, the State Revenue Minister had agreed that agricultural land ceiling limit be lowered for a family of 5 members to 5 hectares for the best category of land with assured irrigation and capable of raising at least two crops in a year, 7.5 hectares for the next category with assured irrigation for at least one crop a year, and 12 hectares for the rest;

DHILLON): (a) to (b) Abbording to the consensus arrived at in the Revenue Ministers' Conference, this issue was left to be considered by the State Governments and the hUnion Territories, All the States/Union Territory Administrations have not yet taken a final view on the issue.

THE MINISTER OF AGRI-CULTURE (SHRI G. S. DHILLON): (a) Price mechanism is one of the incentive given to the farmers.

(b) Cost of production is governed by the prices of inputs as well as by productivity. The Government have been making sustained efforts not only to increase yields but also ensure availability of inputs at reasonable prices for the cultivation of all crops including wheat, rice, pulses and oilseeds.

#### Freight Equalisation in Railways

# THE MINISTER OF STEEL AND MINES (SHRI K.C. PANT):

- (a) and (b) There is no scheme of freight equalisation for Coal. The scheme of freight equalisation is pplicable to iron and steel. The States in the eastern region are deprived of the locational advantage only to the extent of the freight in excess of the normal railway freight for transporting iron and steel.
  - (c) The Government have already decided in principle to thate cut the freight equalitation echeme.
