Neyveli Lignite Corporation

*253. SHRI K. GOPALAN: SHRI V. GOPALSAMY:

Will the Minister of ENERGY be pleas. ed to state:

- (a) whether it is a fact that Neyveli Lignite Corporation is planning to start a third mine cut in its mines;
- (b) if so, what are its salient features and how much amount is going to be invested and how much lignite is expected to be produced in the coming years; and
- (c) how long the present stock is expected to last?

THE MINISTER OF ENERGY (SHRI VASANT SATHE): (a) to (c) Neyveli Lignite Corporation has prepared a feasibility report for opening a third mine with a production capacity of 11 million tonnes of lignite per annum at an estimated capital cost of Rs. 1208.60 crores (excluding interest during construction of Rs. 88.79 crows) December, 1983 prices.

The Third Mine spread over an men of 38 sq. kmis. is estimated to have a reserve of 470 million tonnes of Lignite. At the rate of production of 11 million tonnes per annum, the life of the mine would be about 43 years.

The project proposal has, however, not seen included in the Seventh Five Year ³lan due to resource constraints.

- (c) whether Government propose to take suitable measures to ensure the availability of all essential drugs for treatment of cancer at reasonable prices to the patients[^] through the net-work of super bazars and other cooperative drug stores?

THE MINISTER OF INDUSTRY AND MINISTER OF PETROLEUM AND NATURAL GAS (SHRI NARAYAN DATT TIWARI): (a) No, Sir. The price, of Anti-Cancer drugs are controlled under Drugs (Prices Control) Order. 1979. The imports are permitted under open general licence of Current Import and Export Policy. The retail prices of these formulations manily depend on the prevailing international market rates.

- (b) The names of commonly imported Anti-Cancer drugs are given in the statement (See below).
- (c) This Department monitors the availability of important life saving drug formulations including anticancer drugs in the country based on the periodical reports received, from State Drug Controllers, and 7.onal offices of the Central Drug Control Organization. These drugs are available at Government fixed prices through the Pharmaceutical trade.
