Resumption of rocket launches from Sriharlkota

1544. SHRIMATI RENUKA CHO-WDHURY. Will the PRIMS MINISTER be pleased to state;

(a) whether it is a fact that the Sriharikota rocket launching station in Andhra Pradesh was samaged in a cyclone last year;

(b) whether launching of rockets has been resumed from this station after makine necessa'ry repairs/modifications at the station;

(c) what is the number of satellite proposed to be launched from this station -. and the purpose to be served by these launches; and

(d) whether there are any plans to expand the rocket launching station at Sriharikota?

THE MINISTER OF STATE IN THE MINISTRY OF SCIENCE AND TECHNOLOGY AND IN THE DE-PARTMENTS OF OCEAN DEVELOP-MENT, ATOMIC ENERGY, ELECT-RONICS AND SPACE (SHRI SHIVRAJ PATIL); (a) There was no serious damage as a result of cyclones last year, that is, 1985. However extensive damages occured at Sriharikota on account of a severe cyclone in November, 1984.

(b) Launching of sounding rockets from Sriharikota was resumed after necessary repairs| modifications to facilities damaged during the 1984 cyclone.

(c) As per the approved Space Programme, the Launching of Stretched Rohini Satellite Series (SROSS) (150 kg. Class Satellites) using the Augmented Satellite Launch Vehicle (ASLV), and an Indian Remote Sensing Satellite (IRS) (1000 kg. Class satellite) utilising the Polar Satellite Launch Vehicle (PSLV), from Sriharikota, are planned in the next few years The SROSS satellites will carry out scientific, and technological experiments and the IRS satellite will be used for remote sensing applications.

(d) Augmentation of the existing facilities, depending upon the needs, is a continuous process, and action in this regard is taken as and when necessary.

Manufacture of electronic grade laminates by M/s. OAK India Ltd.

(a) whether it is a fact that M|B. Oak India Ltd. is going to set up a plant to manufacture electronic grade laminates-

(c) whether the proposed plant is likely to save the country from the import of laminates and if so, the estimated expected savings of foreign exchange?

Hteroin Racket in Delhi

Heroin Racket is on the increase in Delhi;

(b) how much quantity of Heroin has been seized from January, 1985 till June, 1986; and

THE MINISTER OF STATE IN THE MIN1STRD3S OF PERSONNEL, PUBLIC GRIEVANCES AND PEN-SIONS AND THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI P. CHIDAMBARAM): (a) Yes, Sir.

(b) 3 Quintals 63.5 Kilograms in Delhi.

(c) The following steps are being taken by the Government in this re- ; gard:--

(i) Some active drug traffickers! smugglers operating? Inter-State and to Questions

internationally have been identified. Constant watch is being maintained on them and on the drug pedlaraj smugglers who are receiving consignments from the traffickers.

(ii) Extra efforts have been made by Delhi Police through the Police Station Special Staff and the anti-Narcotic sections of the Crime Branch to drug apprehend the pedlars traffickers/smugglers and make seizures. Since the inception of the Narcotic Drug's & Psychotropic Substances Act, 1985, the various Branches of Delhi Police launched a Special drive against Narcotics, particularly Heroin and Smack.

(iii) Close liaison is being maintained with the other enforcement agencies, specially in the cases where inter-State or international trafficking is found or suspected. The traffickers|pedlars|smugglere are being interrogated to unearth the syndicates.

(iv) Special watch is being maintained at the entry and exit points of the U.T. of Delhi. Some significant seizures have been made at the borders, Railway Stations and Bus Stops.

Ban on flow of fore-'gn money to *certain* organisations
