boats were operated during Sixth Five Year Plan.

- (d) All the schemes mentioned under (b) above except the joint venture for production and marketing of Fibreglass Reinforced Plastic boats and scheme for Motorisation of Traditional Craft are ongoing schemes.
- (e) A Regional project on development of small scale fisheries in Bay of Bengal with Swedish International Development Agency/ Food and Agricultural Organisation of United Nations assistance is now under implementation. Some of the a important components under the above project for increasing the fish production are:-
  - (i) Development of Pen Culture, and:
  - (ii) Introduction of Beach Landing Craft.

- (c) and (d) The housing programme of D.D.A. is not linked with the 5 year plan and no target was fixed. During the period 1980-81 to 1984-85 64,233 houses were constructed by DDA under the various categories.
- (d) The total number of registrants waiting allotment is 1,61,679. Efforts are being made to complete the maximum number of houses within the available resources.

## Funds for Increasing Road Kilometreage in Madhya Pradesh

- 1594. SHRI AJIT P. K. JOGI : Will the Minister of AGRICUL-TURE be pleased to state:
- (a) whether the Indian Road Congress in their deliberation at Trivandrum in 1984 resolved to connect all villages with less than 1000 population by roads within a definite time frame;
- (b) whether the Madhya Pradesh -Government submitted proposals of Rs. 669.00 crores for the aforesaid purpose in the seventh five year plan by the Planning Commission approved an outlay of only Rs. 281.39 crores; and
- (c) if so, whether Government propose to reconsider the demand of the Madhya Pradesh Government especially in view of the fact that the State's road kilometreage per 100 sq. kilometre of area is far below the national average?

THE MINISTER OF STATE IN THE DEPARTMENT OF RURAL DEVELOPMENT (SHRI RAMA-NAND YADAV) : (a) The council of the Indian Road Congress in. their 111th meetting held at Trivandrum on 15th Sepember. 1984 approved the draft Road Development Plan for India (1981-2001) emphasises the need to achieve the full connectivity by road to all the villages by the turn of the Century.

(b) and (c) In their draft Seventh Plan for roads and bridges, the State PWD mentioned that their minimum requirments for development was Rs. 669 croves for the Seventh Plan. Madhya Pradesh State Planning. Economics & Statistics Deptt. had, however, communicated a proposed outlay of Rs. 281.39 crores. Since the Government in their Plan proposals to the Planning Commission, Government of India indicated requirement of Rs. 281.39 crores only for roads and bridges, the same was agreed to by the Planning Commssion.

## Electric and Water Connection to Quarters in Kali Bari Marg. New Delhi

1595. DR. G. VIJAYA MOHAN REDDY : Will the Minister of URBAN DEVELOPMENT pleased to refer to the answer to Unstarred Question 1435 given in the Rajya Sabha on the 9th May, 1986 and State .

- (a) whether NDMC has been approached for giving electric and water Connections to 90 type [1] quarters at Kali Bari Marg. New Delhi which were completed 31st March, 1986;
- (b) if so, by what date NDMC has promised to provide electric and water connections to the above quarters : and
- (c) Whether any quarters out of these 90 type III quarters have been earmarked for the Lok Sabha/Rajya Sabha Secretariat employees?...

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT (SHRI DALBIR SINGH): (a) and (b) The electric and water connections to 90 type III quarters at Kali Bari Marg, New Delhi have been provided by NDMC.

(c) Out of these 90 type III quarters none of the quarters has been earmarked for t he Sabha/Raiya Sabha Secretariat employees.

## Government Quarters in Vasant Vihar. New Delhi

1596. SHRI KAPIL VERMA: Will the Minister of URBAN DE-VELOPMENT be pleased to state:

- (a) whether it is a fact that type I, II and III quarters in Vasant Vihar Delhi are ready for occupation by the eligible Central Government employees:
- (b) whether it is also a fact that the Directorate of Estates is not in a position to allot these quarters due to non-availability of elecconnections: tric and water
- (c) whether the Ministry Urban Development has approached the Municipal Corporation of Delhi for the supply of electric and water connections for these quarters at Vasant Vihar; and
- (d) if so, when MCD has promised to supply these connections?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT (SHRI DALBIR SINGH): (a) No Type I and Type II Quarters are under consideration in General Pool in Vasant Vihar. However. 615 Type III quarters are under construction in General Pool. 400 Type III quarters have been completed except for testing of services and final coat of finishing. These items can be taken up only after the water and electric connections are available.
