- (b) if so, what are the details thereof; and
- (c) what is the reaction of Govern ment thereto?

THE MINISTER OF STATE IN THE DEPARTMENT OF INDUSTRIAL DEVELOPMENT (SHKI M. ARUNACHALAM): (a) to (c) Association of Indian Engineering Industry has made following' suggestions which have been noted by the Government.

- 1. The following recommendations of the Abid Hussain Committee should be implemented:—
- (a)" Nil or negligible imoprt duty in case of capital goods where there is no dome:tic production. (A list should be formulated jointly by Government and Industry).
- (b) For a range of capital goods where domestic production has been in existence for a decade or two, de-escalate protection in a phased manner (Taking into account input cost diffierentials).
- (c) Import licence procedure for residual category of capital goods to be continued after rationalisation of tariff structure.
- 2- Ban on imports should be i»l" posed after strict screening of indigenous products.
- 3. Imoprt of caiptal goods against REP licences and similar other facilities should be strictly screen ed from the angle of indigenous availablity.
- 4. Import of second-hanri machin ery should not be allowed. This is contrary to technological upgra dation.
- 5. The policy should provide some special protection to Indian capital goods industry at limes when foreign suppliers dump their products in Indian markets.

6, List of capital goods under OGL should be circulated before implementation.
