- (a) whether in view of power shortage in Kerala due to failure of monsoons, Government consider it necessary to expedite the work 400 KV transmission line between Ramagundam-Salem-Trichur.
- (b) if so, whether any revised schedule for commissioning of the lines has been drawn up, if not, the reasons therefor;
- (c) how far the work has progressed till 31st July, 1986;

- (d) how much amount has been spent on this line till date; and
- (e) how much more is expected to be spent to complete the project?

THE MINISTER OF STATE IN THE DEPARTMENT OF POWER AND MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRIMATI SUS-HILA ROHATGI): (a) and (b) The Ramagundam-Salem-Trichur mission line is 1413 circuit kilometers long. The transmission line is scheduled for commissioning in 1989-90. Considering the size of the project it would not be possible to commission this line earlier. However, every effort is being made to obviate delays in the construction of this line.

- (c) Till 31st July, 1986, 858 circuit kilometers of line from Ramagundam. to Bangalore had been completed.
- (d) and (e) The estimated cost of the transmission line including the of the associated sub-tations and switching-stations is Rs. 246.12 crores against which a sum of about Rs 112 crores has been spent upte June, 1986.
