- (c) whether Government have made any indepth study into the use of Koir Pyth Stove made out of GI Sheet; and
- (d) whether Government consider his invention as successful, in view of the energy crisis the country is facing?

THE MINISTER OF ENERGY (SHRI VASANT SATHE): (a) to (d) A proposal from Sri Venkatesa & Co. Tiruchirapally signed by Shri A.T.R. Swamy was received in this Department on 2.5.86 requesting for the approval of Sri Venkatesa & Cois Coir Pyth Stove. Shri Venkatesa & Co. was. requested on 25-5-86 to get the efficiency of this stove tested by the Central Power Research and the Indian Institute of Technology, Delhi. This letter was acknowledged by Sri Venkatesa & Co. on 24.6.86 confirming that all documents, had been sent to the two institutions. As per the policy of the Department, a new stove can be approved for propagation under the National Programme of Improved Chulha if its efficiency is certified to be above 20 per cent by at least two independent scientific institutions designated bv Department. Accordingly, the company was requested to get the efficiency of these stoves tes_T ted at the two above mentioned institutes. The report from the Central Power Research Institute, Bangalore shows that the efficiency of the "Sri Venkatesa and Co. Coir Pyth Stove" is 98 per cent. The report from ITT Delhi is awaited.

Supply of LPG Cylinders to Five Star Hotels etc.

THE MINISTER OF 'STATE IN THE DEPARTMENT OF POWER AND MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRIMATI SU-SHILA ROHATGI): (a) and Normally no priority in supply of LPG refills is given to five-star hotels, hospitals and hostels. However during periods of sustained backlog, dealers are advised to accord priority in supply of refills to hospitals, hostels and hotels who may not find it possible to Use alternative fuels

(b) There have been no serious complaints in this regard.
