New Express and Super Fast Trains Introduced during the Sixth Five-Year¹ Plan.

(c) how many new Express and Super Fast Express trains are proposed to be introduced in each Railway zone during the Seventh Five Year Plan; and

(d) what are the criteria applied for introducing new Express and Super Fast Express trains and whether traffic surveys are being conducted along with financial studies, to the effect, if so, what are the details thereof during the last three year; in each zone?

The information is given in Annexure. [See Appendix CXXXIX, Annexure No. 109] Data about number of passengers per km. trainwise are not being maintained.

(c) Trains already introduced during the first two years and proposed to be introduced from 1st October, 1986 are indicated in Annexure. [See Appendix CXXXIX, Annexure No. 110] For the remaining year, of the 7th Plan no decision has been taken yet.

(d) Criteria for introducing new trains are mainly the need based requirements of the various sections, the overcrowding on trains, operational feasibility and the Railways' resource position.
