Dinesh Singh Commission on riots in Tripura

- 2140. SHRI NARAYAN KAR: Will the Minister of HOME AFFAIRS pleased to state:

THE MINISTER OF STATE IN THE DEPARTMENT OF STATES (SHRI GHULAM NABI AZAD): (a) Government of India had constituted Dinesh Singh Committee in July, 1980 to suggest measures for speedy restoration of normalcy, relief and rehabilitation of the riot victims and to bring about harmonious relations among the sections of the population in Tripura.

- (b) The Committee submitted its Report on 7-8-1980.
- (c) and (d) A copy of the Report of Dinesh Singh Committee was laid on the Table of the House on 11th August, 1980. The recommendations were communicated to the State Government and all concerned authorities for necessary action. The Government is alive to the accelerated development of Tripura and is taking necessary action in this direction
