Intermittent Firing by Pakistani Troops in Jammu and Kashmir

13. SHRI RAM NARESH KUSHAWAHA: Will the PRIME MINISTER be pleased to state:

(a) whether it is a fact that Pakistani troops have been continuing intermittent firing on Indian positions on the Jammu and Kashmir border since August, 1985 and of late they have intensified their military activities by installing sophisticated weapon systems in the border region; and

(b) if so, what are the details in this regard, stating the number of casualties suffered so far on either side and the steps taken by Government to strengthen the Indian position to meet any eventuality?

THE MINISTER OF STATE IN THE DEPARTMENT OF DEFENCE RESEARCH AND DEVELOPMENT (SHRI ARUN SINGH): (a) and (b) There have been some cases of firing by Pakistani troops on our positions along the Line of Control in Jammu and Kashmir since August, 1985, resulting in some casualties on both sides. It would not be desirable to disclose details in this regard.

Government have no report to indicate intensification of military activities by Pakistani troops across the border in Jammu and Kashmir.

There have been some cases of unprovoked firing by Pakistani troops along the Line of Control in Poonch and Rajouri areas. Such firing incidents are not uncommon.

Non-clearance of Bhensatori Irrigation Project in Madhya Pradesh by the Central Government

(b) The proposal for diversion of forest land for Bhensatori Project was approved by the Central Government. The State Government has reported that 36709 trees standing over forest land were likely to be suo ed if the project was implemented.

(c) According to the latest enumeration, 35097 trees are standing over' this forest land.

(c) The Central Government makes allocation of imported edible oils to States/Union Territories lor distribu- tion to consumers through Fair Price Shops. It is the responsibility of tha State Government to take proper sti to ensure that the imported oils are distributed to the consumers through Fair Price Shops. The State Govern- ments have been advised to streamline and energise the public distribution system to ensure that' the imported oils actually reach the consumers and also to furnish' monthly certificate in- dicating that, the imported edible oils has been fully lifted and ihe same has been properly utilised for the pur- pose for which it has been allotted. The officers of the Central Govern- also visit the States/Union Terri- tories to check that the imported oil etc. is available at th_e Fair Price Shops and distributed to consumers ' for whom it is meant.
