- (b) if so, whether the alternative sites/ accommodation would ge on par in terms of commercial value and business potentiality with the sites which are presently occupied by the shopkeepers; and

THE MINISTER OF URBAN DEVE-LOPMENT (SHRI ABDUL GHAFOOR):

- (a) Yes, Sir. Alternative plots or stalls would be allotted to all those who fulfil the criterian of eligibility in regard to duration of occupation etc.
- and (c) No, Sir. Shopkeepers would be allotted alternative accommodation similar to that allotted to the commercial evictees under the Slum Clearance Programme and their cases would considered by the Slum Department of the DDA.
