

Report of BICP on tyre prices

188. SHRI SURESH PACHO-URI : Will the MINISTER OF INDUSTRY be pleased to state :

(a) whether Government have received the report of the Bureau of Industrial Costs and Price on the rise in price of tyres manufactured in the country ;

(b) if so, what are the salient features thereof ;

(c) whether it is a fact that the tyre manufacturers were advised by Government not to raise the price of tyres before the report of the BICP was received ;

(d) whether it is also a fact that the tyre manufacturers have ignored this advice and raised the price of tyres ;

(e) if so, what are the details in this regard and the extents to which prices of tyres have been raised ; and

(f) what is the reaction of Government in regard thereto ?

(a) and (b) Yes, Sir. An edited version of the Report has been made public and copies of the same are available in the Parliament Library for ready reference.

(c) There is no statutory control on the prices/distillates at present. In the control on price of raw material conversion costs and the prevailing competitive market conditions, prices are determined by market forces of demand and supply. According to Automotive Tyre Manufacturers' Association, an apex body of the tyre manufacturers, the recent price increase has been restricted to 5% on tyres and 6 to 7% on tubes against

full unabsorbed cost increase of 9.68% and 13.66% respectively. The Government has been using persuasive methods by interacting with both the tyre industry and raw material manufacturers in the matter.

(b) whether it is a fact that there is a flood of different brands of toilet soaps, mostly costly in the market ;

(c) whether the CERC has made any observations that basic ingredients in all toilet soaps are generally same and it is mainly, the packing and publicity which give rise to high prices of so-called luxury soaps;

(d) what are the other observations of the CERC ; and

(e) what is the reaction of Government in regard thereto and what action has been taken or proposed to be taken in the matter ?
