Setting up of 'Yatri Niwas' at hill stations

- 345. SHRI SURESH PACHOURI; Will the Minister of TOURISM be pleased to state:
- (a) whether Government are aware of the need of "Yatri Niwas' at hill stations in the country to encourage middle income group tourists:
- (b) if so, the names of hill stations where the facility of 'Yatri Niwas' is available alongwith the number of persons who can be accommodated there at one time at each place;
- (c) whether it is a fact that there is dire need of a 'Yatri Niwas' at Shimla to encourage the middle income group tourists;
- (d) if so, what are the proposals of the Tourism Ministry to construct 'Yatri Niwas' in Shimla and by when such a 'Yatri Niwas' is likely to be constructed?

THE MINISTER OF TOURISM (SHRI MUFTI MOHD. SYED): (a) Yes, Sir.

- (b) At present no hili station in India has a Yatri Niwas constructed by the Ministry of Tourism as th? scheme was launched only during 1985-86. A Yatri Niwas for Darjeeling with a capac'ty of 104 beds has been sanctioned recently and one for Pahalgam, is under process.
 - (c) Yes, Sir.
- (d) Proposals had been invited from all States and UTs for construction of Yatri Niwas at selected locations of tourist importance. The proposal fr'om Govt, of Himachal Pradesh for constructing a Yatri Niwas at Shimla was received only last week and should be cleared within four weeks.

Gold Control Act

- 346. SHRI J. P. GOYAL: Will the Minister of FINANCE be pleased to stale:
- (a) whether Government are aware of the failivffi of the Gold Control Act to achieve all its objectives;

- (b) if so, whether the bullion trade has strongly pleaded for the repealing of the Gold Control Act; and
- (c) what i_s the reaction of Government in regard thereto and what are the hindrances in the way of repealing the Gold Control Act?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI JA-NARDHAN POOJARI): (a) to (c) The Government have been receiving representations from time to time from the Trade as also from private parties etc. alleging interalia that the Gold Control Act has failed to achieve the objectives for which it was introduced and that it should be repealed. Keeping in view these reprsentations, the Government have set up two working groups-one to go into the Gold Control policy i_n aU its aspects and the other to review the working of the Gold Control machinery etc. The question whether the Gold Controi Act should be repealed would he considered when the reports of these two working groups becomes available.

Scheme for organising Sports, Games, Si, ial and Cultural aclivities for Beedi Workers 'ncluding Ghar Khata Beedi Workers).

INTRODUCTION:

The Sports Games, Social and Cultural activities are the forms of recreation which Beedi Workers with his family members can use to inculcate in them a bit of outdoor life to invigorate their minds and refreshen their tortured bodies. It will also give them a sense of mental and physical satisfaction so essential for the development of good human relations. It will afford I hem an opportunity to escape from the monotony of day-to-day humduram existence of crouching in the unhygienic sheds and shanties and to roll out beedies almost during twelve hours a day.

AGENCIES:

It could be arranged by the Welfare Commissioner through his staff or by giving subsidy to the managements or to social and cultural organisations of repute. 1 could also be arranged through workers'

voluntary organisations like Workers' Recreation Club which could be formed with, the advice of the Welfare Commissioner with a view io giving workers a sense of participation in the whole scheme.

Written Answers

NATURE OF SPORTS, GAMES, SOCIAL AND CULTURAL ACTIVITIES:

Only such outdoor/indoor Sports, Games, Social and Cultural events will be arranged as ar_e popular with the Beedi Workers (including Ghar Khata Beedi Workers) and their family members in a particular area.

Social activities should include social functions like celebration of National and Regional festivals, important National events like the Independence Day, the Republic Day, the Gandhi Jayanthi and the Childrens' Day and the like.

LOCATION OF EVENTS:

The functions will be arranged in areas where the concentration of beedi workers is 10,000 or more.

EXPENDITURE:

Item on which expenditure can be incurred would be (i) Sports activities like articles of sports—out-door and indoor games and equipment (ii) Cultural activities like music% dance, drama, mushiaras, Jag-ran, festivals etc. (iii) Light refreshment (iv) Prizes (v) Arrangement (vi) Social activities like National. Regional Festivals and National Days.

Th© total expenditure for the whole year fcr an area having a population of beedi workers of 10,000 or more should not exceed Rs. 10,000'- subject to the limitations of budget provision as approved by the Government of India will be met from the Welfare Fund.

MANNER OF PAYMENTS:

A. If the event is to be held by the Welfare Organisation, the Welfare Commissioner wil! have to obtain the sanction of the Ministry of Labour giving full justification for holding the event and items on

which the expenditure will b_e incurred. He will spend the amount only on receipt of the sanction letter from the Ministry.

- B. However, if it i_s to be arranged by a management or Voluntary Organisation, the Welfare Commissioner will reimburse 50 per cent of the cost of the event subject t₀ a maximum of Rs. 2,000/- per event_< after it has bee_n incurred, with the approval/sanction of the Ministry of Labour. On conclusion of the event, the management/voluntary organisation shall submit their claim with the following particulars:—
 - (1) Nature of the event.
 - (2) List of participants.
 - (3) Original bills /other supporting documents with the required certificate?.
 - (4) The stamped acquittance from Ihe participants of the amount received and on what account.
 - (5) Advance stamped' receipt for the amount payable by the Welfare Organisation, duly signed and sealed by the management or voluntary organisation.
 - (6) A detailed report about the event.
