It js) therefore, necessary to coinise these denominations. However, having regard to the continuing public preference for these notes, complete replacement of these notes within. a short by coins period would not be desirable. Efforts are, therefore, being made not only to augment coin production facilities but also increase the printing of one rupee and iwo rupee notes.

Declaration of Tourism a* an Industry

- 271. SHRI B. SATYANARAYAN REDDY: Will the Minister of TOURISM be pleased to state;

- (c) what special efforts are being made by Government to promote tourism in the country; and

THE MINISTER OF TOURISM (SHRI MUFTI MOHD. SYED); (a) and (b) In July 1984, the National Development Council recommended that Tourism should be accorded the status of an industry. Accordingly, the State Governments were requested to declare Tourism as an industry. Some of the State Governments have already declared Tourism Hotels as industry and other State Governments have again been requested to declare Tourism Hotels 'as industry.

- (c) Several steps are being taken to promote Tourism in the country, which include provision Of tourism infrastructure at important tourist centres, promotion of domestic tourism through special campaigns, improvement in the quality of surface transport, development of wildlife Tourism, promotion of charters, emphasis on direct consumer 'advertising abroad and production of improved publicity material. participation in food festivals, travel Seminars and exhibitions in tourist generating count-ies.
- (d) Development of tourist centres is taken up in consultation with State Governments concerned. During 1985-86 development projects were sanctioned for Pakhal Lake. Leepakshi, Nagarajuna Sagar and R'shikonda During the Seventh Five Year piin. more centres will be taken up for development in consultation with the State Gavernment.
