The economic status of rural poor in the dairy cooperatives is improved by a regular payment of remuround the year, nerative prices providing market for rurally produced milk and economically priced inputs for increasing milk production

As a result of implementation of Operation Flood I & II along other milk production enhancement programmes taken up under Central, Centrally Sponsored and other State Sector Schemes, the estimated milk production in the country has increased from 216 million tonnes in 1969-70 to 42.3 million tonnes (anticipated) in 1985-86.

(c) The Accepted policy of the Government is to foster and promote dairy development on cooperative lines as far as possible. With this in a National Dairy Project. known as Operation Flood has been launched in the country. The project in based on a three tier cooperative structure i.e. (i) Village Level Dairy Cooperative Societies of Milk Producers at the grass-root level, providing direct and indirect employment rural areas: (2) Unions of in the these village cooperatives at the district level; and (3) Federations of

these Unions at the State/apex level. The project provides employment in rural areas and helps to raise the income of the poorer sections.
