(c) whether it is also a fact that a two day national conference of State Irrigation and Water Resources Ministers was held at New Delhi on 8th and 9th July, 1986;

(d) if so, what are the details of the discussions held and the outcome thereof; and

(e) what progress has so far been made with regard to the formulation of a National Water Policy?

THE MINISTER OF WATER RE-SOURCES (SHRI B. SHANKARA-NAND): (a) Yes, Sir.

(b) Subjects discussed include integrated water resources planning and development, utilisation of irrigation potential, cyclones, floods, and droughts, man-power planning, training and research, tribal subplans, special component plans, etc.

(c) Yes, Sir.

(d) Important issues arising out of the regional Conferences of Irrigation and Water Resources Ministers were discussed at the National Conference, and in the concluding session held on 21st July, 1986, recommendations/decisions were finalised regarding basin master-plan, catchment environment and forest treatment, clearance, projects clearance, prioritisation of on-going projects, funding for projects, water rates drought management etc.

(e) The draft of the National Water Policy is under preparation.

THE MINISTER OF STATE OF THE MINISTRY OF INFORMATION & BROADCASTING (SHRI V. N. GADGIL): (a) Reports to this effect appearing in the Press have come to the notice of the Government.

(b) According to the Press reports, the closure had been called for as a mark of protest against the alleged arbitrary policy of the Government in the matter of allowing higher quantum of Interim Relief to the Newspartr Employees, increase in newsprint prices, low rates for Government advertisements etc.

The Government is fully committed  $t_0$  the growth of a free Press in the country and has been taking all possible steps in a rational manner for its overall development within the constraints posed by limited availability of country's resources.
