

(c) what are the details of the estimate cost of each of these proposed fishing harbours to be set up in Orissa?

**THE MINISTER OF STATE IN THE DEPARTMENT OF AGRICULTURE AND COOPERATION (SHRI YOGENDRA MAKWANA):** (a) An outlay of Rs. 1700 lakhs for Fishing Harbours at major ports and Rs. 1800 lakhs for fishing harbours at minor ports is provided in the Seventh Plan. The expenditure on the fishing harbours that may be sanctioned for Orissa during the Seventh Plan will be met out of the said outlay.

(b) and (c) (i) A proposal for construction of a minor fishing harbour at Gopalpur at an estimated cost of Rs. 599 lakhs is kept in abeyance due to constraint of fund.

(ii) A proposal for the construction of a landing centre at Rushikulya at an estimated cost of Rs. 5.70 lakhs is under examination in consultation with Government of Orissa.

(iii) A detailed project Report for the construction of a Fishing Harbour at Paradip is awaited from the Paradip Port Trust.

**Census of denotified, nomadic and semi-nomadic tribes**

#### Statement

According to the State Government of Orissa, special attention has been given for economic development of the specially vulnerable groups including the denotified, nomadic and semi-nomadic tribes.

For this purpose socio-economic survey has been taken up by the State Government.

With a view to making the economic development programmes for the specially vulnerable groups effective steps have been taken by the State Government to identify functional clusters of these families. For example, Kelaś residing in a cluster in Puri district have been covered in an action plan for their economic development. Another example is that of Dandasis, for 2000 of them in one cluster a detailed survey and project report is under preparation.

Rs. 62 lakhs out of Special Central Assistance has been provided during 1985-86 for the development of Special Vulnerable Groups. The provision during 1986-87 is Rs. 70.00 lakhs and the physical target is to cover 3000 such families.
